**“Royalty Exemption / and or Fee  
Reduction Form”  
per Aggregate Resources Act**

**Royalty**

4. (2) A permittee or licensee is exempt from paying royalties with respect to aggregate or topsoil that is Crown property and that is supplied by the permittee or licensee for use in projects of the Province of Ontario if the purchase price of the aggregate or topsoil supplied does not include an amount on account of the royalties.

**Annual Permit Fees**

2.2 (2) For the purpose of determining the amount of an annual fee payable under this section, the amount determined under subclause (1) (a) (i) or (1) (b) (i), as the case may be, shall be reduced in accordance with subsection (3) if the holder of the aggregate permit is a person other than the Crown and all of the following circumstances exist:

1. The area of the site at which the aggregate or topsoil was excavated is located in an unorganized territory or in a single-tier municipality other than a designated single-tier municipality.
2. The aggregate or topsoil that was excavated is Crown property.
3. The aggregate or topsoil that was excavated is supplied for,
  - i. In the case of either aggregate or topsoil, a project of the Province of Ontario.
4. The purchase price of the aggregate or topsoil supplied does not include an amount on account of the fee.

2.2 (3) The amount of a reduction to the amount determined under subclause (1) (a) (i) or (1) (b) (i) as the case may be, shall be equal to,

- (a) Twenty-five thirty-thirds of the amount, if the area of the site at which the aggregate or topsoil was excavated is located within an unorganized territory; or
- (b) Five thirty-thirds of the amount, if the area of the site at which the aggregate or topsoil was excavated is located within a single-tier municipality, other than a designated single-tier municipality.
